The Eversense® 365 CGM system (product code SBA) received FDA clearance through the 510k process on September 16, 2024. The device is indicated for continually measuring glucose levels for up to one year in individuals (18 years or older) with diabetes. The system is indicated for use to replace fingerstick blood glucose measurements for diabetes treatment decisions and can be used alone or in conjunction with digitally connected medical devices for the purpose of managing diabetes.
